President's Letter

Greetings! Summer is finally with us in all its glory. I'm in Montana and can never remember the state so green and lush. The wildflowers are every bit as beautiful as any of our gardens...maybe with a little less work.

The Board of Directors is already working on league activities that will keep our league visible and relevant in the community with a focus on increasing our membership. What can you do to help? If you have an interest in promoting the League's image and activities in the community and inform the public of the League's services, positions, membership opportunities and fundraising efforts - call me. I will work with you to take advantage of new ways to promote the league.

What's going on in the league right now?

In June Roberta Jacobson and I attended **The LWVIL 54th State Convention, "Everyone Counts...On League and In League"**, along with 35 other local leagues and ILOs. We were both impressed with the overall process and the detail of the breakout sessions, as well as the opportunity to network with and learn how other leagues work on issues.

You will not be surprised with the 2009-2011 Action Focus of:

- Fiscal Policy and Tax Reform (*including school funding & social services*)
- Campaign Finance and Ethics Reform.
- True Census Count 2010 and Redistricting Reform.

The adopted Will of Convention called for restoration of the state's fiscal health and to provide for Illinois' future, lowering the campaign finance limits to the federal level and treating t transfers and in-kind contributions from other candidates on the same basis, and urging he Governor to veto HB 182, that would allow a person to carry

concealed handguns into another person's home. Look for a little more detail inside this *Voter* and at www.lwvil.org.

The Diversity Committee is working on increasing the visibility of the league through a “**Colorful Discussions**” project and is working to involve the College of DuPage as a partner. The idea is to conduct free, regular (perhaps, monthly) coffeehouse type moderated discussions on current, nonpartisan issues by diverse citizens. Other leagues have successfully used “Hot Topics” discussions to increase both visibility and membership.

Both the House of Representatives and the Senate are working to pass **Health Care Reform** legislation in the next few months so expect to see more information and requests for action from LWVUS and our own Health Care Committee.

The Wheaton LWV is taking a leadership role in DuPage County, working with Mary Schaafsma and the other leagues in the county on the **True Census Count 2010 and Redistricting Reform** project. A 2 year grant from the Joyce Foundation allowed the LWVIL to hire Mary to work with local Leagues of Women Voters to publicize the importance of the 2010 census; join efforts with other stakeholders to make sure that Illinois is fully counted, including, in particular, those areas considered “hard to count;” partner with the U.S. Census Bureau to increase response rate; and, encourage Complete Count Committees throughout Illinois. Expect more to information on this project.

September is always a busy month for league: time to pay your membership dues, think about what committee to work with, make reservations for the **Fall Feast**, watch for action alerts emails to act on, and catch up with fellow leaguers after the summer break. One thing I know you will hear from me regularly is **growing league membership** and the most important way to do that is to **ASK** others to join and **ASK** often... This year you are encouraged to invite someone to come to the Fall Feast for a great meal, an interesting topic and learn more about the League of Women Voters. I look forward to meeting some potential new members. See you then!

Understanding LWV Appeals

To help LWV of Wheaton members understand **when to pay membership dues** and **how to plan for other fundraising appeals** scheduled for 2009/2010 by local, state and national Leagues, we prepared the chart below.

In **August 2009**, expect to receive a notice by regular mail for your membership dues, which are due in September. You must pay by January 1st or your membership will lapse. Members joining after January 31 will pay one-half the annual dues for the year.

In **late September**, you will have an opportunity to make an **additional donation** to support LWV of Wheaton activities as part of our annual Finance Drive.

In October, LWVUS does a telemarketing appeal.

In **November**, LWV of Illinois sends out letters, and if you do not donate before then, they follow up with a phone call (Phonathon) in March 2010.

By January 1, 2010, your Wheaton League must pay the PMP to LWVUS and LWVIL and have an accurate member count.

Workgroup Synopsis

Diversity

The Diversity Team accepted an invitation from the Governor's Office of New Americans Policy and Advocacy to participate with a number of State of Illinois Partners and DuPage Community Partners in the Second Annual Illinois Welcoming Day, which was held on Saturday, May 30, 2009 at the College of DuPage. Our purpose was to welcome new immigrants, refugees, and citizens, and to promote the League of Women Voters of Wheaton. In accordance with LWV rules, our table was set apart from another table of our League which offered voter registration services.

Although we were prepared to serve hundreds of new Americans – we were told last year's attendance exceeded 1,000 – less than a score of people stopped by our table. However, since we had adequate staffing throughout the four-hour period, we used this unique opportunity to network with other organizations with tables in the COD Commons Area. This turned out to be extremely fruitful.

One idea that was discussed was the need for a place in DuPage County, like the Commons, where members of all segments of DuPage County's increasingly diverse population would feel comfortable in joining regular discussions of common interest. Many of the people staffing other tables seemed excited about the concept we now call "Colorful Discussions." As a result, the Diversity team is developing the concept in partnership with the Diversity Office of the College of DuPage. A proposal describing a Colorful Discussions program is being drafted which will be submitted to the boards of both parties for approval. The approval process will involve full compliance with the nonpartisan rules and regulations of the LWV at all levels and of the College of DuPage.

If approval is obtained, the Diversity Teams of both the Wheaton League and COD would convene a diverse planning group to conduct free, regular (perhaps monthly) coffeehouse type moderated discussions of common, nonpartisan issues by diverse citizens. We propose to do this entirely with volunteers, donated services and refreshments, and a zero budget. The hope is that all participants will be edified by the League's outreach to the broader community and its commitment to have increased engagement on important issues with a diverse audience for deliberative, social, promotional, and recruiting purposes.

Environment

Beginning in August, the Electronics Recycling in Wheaton will resume, on the first Saturday, with just one Saturday per month, instead of two,.

There is much work to be done around Wheaton especially in keeping home options available to families and individuals who live on limited incomes. Work is available in DuPage County, even in these difficult economic times, but a place to call home near employment is much more scarce. Not everyone wants to live where they work, but often folks would like to have that option. We all benefit from the neighborhoods in which we live and the good education available in the public school system as well as keeping the commute time and gasoline usage at a minimum, which can best happen when we live near our work.

In Wheaton there is very little un-built land available for housing. However, the redevelopment of our neighborhoods offers families a chance to remain close to resources. How those neighborhoods are redeveloped is a major issue for the Wheaton League of Women Voters. Do we really need to tear down homes or might those structures do well as they are with redecorating inside and out? When a structure is torn down, should a multi-million dollar structure replace a \$300,000 house? What options are available to a developer or potential homeowner that satisfy housing and profit needs?

The League will continue to follow the work of the City Council as it considers the Hubble School property redevelopment and as it works out its options to maintain and add to the affordable housing stock in our great town.

Our first meeting of the new League year will be in the Fall. However, we are part of the DuPage Housing Action Coalition as well as the Benchmark Strategy work, and these meetings are ongoing during the summer.

Give Jan a call or email her or any committee member with ideas you might wish to share with the Action Group. League members are “thinking” people and we want to tap into those ideas and thoughts.

At-Risk Americans: The Uninsured And Underinsured

Data from multiple sources agree that in 2007, 47 million Americans (15.6 percent of the total U.S. population) lacked any kind of health insurance coverage. When these numbers are adjusted for age (excluding those 65 years and older), the uninsured percentage of the population rises to 17.9 percent. Moreover, it is estimated that 25 million adults under age 65 were underinsured during 2007, despite having insurance all year. In total, 42 percent of all adults (86.7 million) were either uninsured or underinsured during 2007.

Putting a face on persons who were uninsured or underinsured during 2007 and 2008¹

- **Age:** One of three people under age 65 were uninsured for some or all of 2007 and 2008; of the total uninsured population, 60.1 million were adults (between 19 and 64 years of age)
- **Duration:** Among the underinsured/uninsured, 74.5 percent were uninsured for nine or more months and one-quarter were uninsured the entire 24 months
- **Employment status:** 80 percent of individuals who were uninsured were in working families and only 16 percent were not in the labor force (due to disabilities, chronic illness, or serving as family caregivers)
- **Income:** Nearly 60 percent were in families with incomes below the federal poverty level (FPL: \$21,200/year for a family of four); 52 percent with incomes between 100 to 200 percent of FPL went without health insurance in 2007/2008
- **Racial and Ethnic origin:** 55 percent of Hispanics/Latinos, 40.3 percent of African Americans and 34 percent of other racial or ethnic minorities had no health insurance in 2007/2008, compared to 25.8 percent of whites. While racial and ethnic minorities are more likely to be uninsured, whites accounted for 49.8 percent of the uninsured
- **Age breakdown:** The likelihood of being uninsured declines with age; 49.5 percent of those 19 – 24 years old, 36.3 percent of those 25 – 44 years old, 32.5 percent of those 45 – 54 years old and 21.2 percent of those 55 – 64 years old were uninsured over this two-year time period. The 55- to 64-year-old age group consumes more health care on average than younger adults.

For all ethnic and racial groups, lower-income families and individuals were more likely to be uninsured than lower-income whites. This disparity continues even as incomes rise in all groups.

There is a marked increase in the number of adults having difficulty paying medical bills – the most visible consequence of the weakening in insurance coverage. In 2007, 41 percent of adults (72 million people) reported problems paying medical bills, faced bill collectors or were in debt for medical care, up from 34 percent or 58 million in 2005. The majority had insurance at the time these bills were incurred² – well in advance of the economic downturn.

3. Urged the Governor to veto HB 182, a bill that would allow a person to carry concealed handguns into another person's home.
